

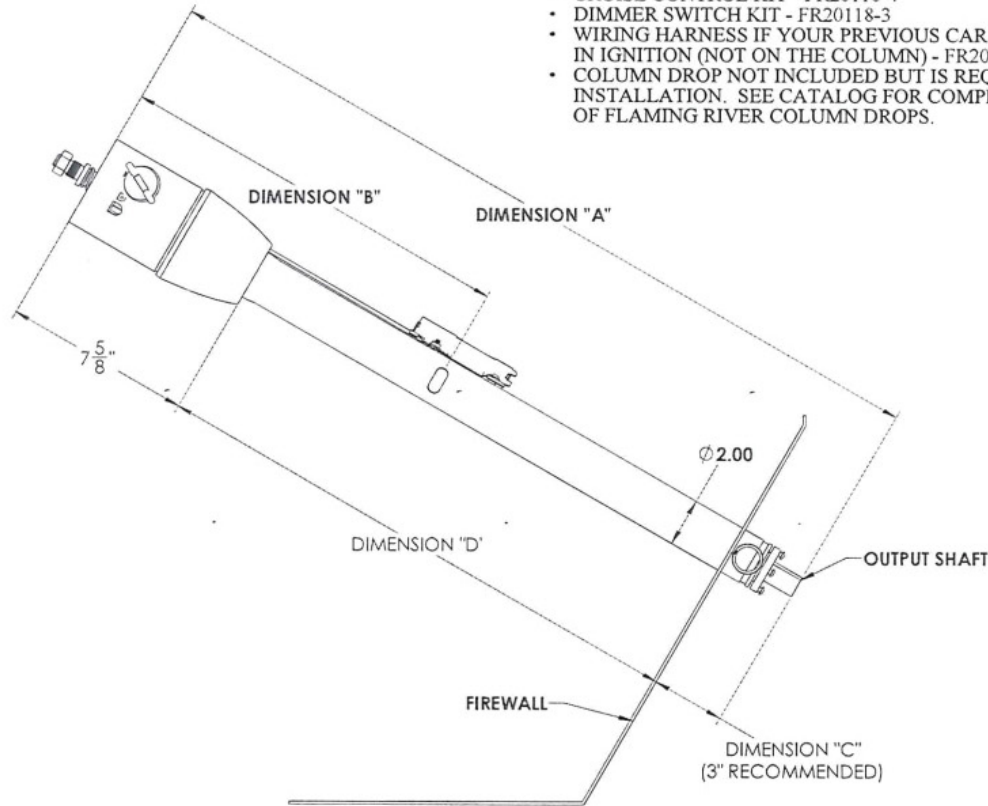

 - A NEUTRAL SAFETY SWITCH IS INCLUDED WITH THIS COLUMN AND WILL BE PLACED IN THE OUR STANDARD POSITION WHICH IS APPROXIMATELY 24.50" FROM THE TOP OF THE SHROUD DOWN, UNLESS OTHERWISE SPECIFIED.
 - KEY SLOT LOCATED AT THREE O'CLOCK POSITION
 - GM CODED KEY ASSEMBLY
 - WIRING AND IGNITION SWITCH
 - TURN SIGNAL, TILT AND HAZARD KNOBS

- **COMMONLY USED ACCESSORIES:**
 - CRUISE CONTROL KIT - FR20118-4
 - DIMMER SWITCH KIT - FR20118-3
 - WIRING HARNESS IF YOUR PREVIOUS CAR HAD BUILT IN IGNITION (NOT ON THE COLUMN) - FR20118-5
